1. General Information:

CMAS Internationals Finswimming Rules Will be applied.

2. Applications form:

Registration

a) The **Preliminary form** of Inscription, hotel reservation (attached form in excel), will have a date of maximum term of sending, 10-07-2010 (July 10th, 2010).

The Final Entry form, (attached form in Excel), will have a date of maximum term of sending, 01-08-2010 (August 01, 2010).

Is obligatory the CODE CMAS in the Final Entry form, per swimmer.

b) The participation costs for the competition are:







The cost or price of participation for the competition is \in 40 per team (\$ 110.000.00 Colombian money) and 15 \in for each swimmer (\$ 45.000.00 Colombian money).

The registration fee will be paid at the technical meeting on Friday August 13-2010, in local currency, Colombian money.

3. <u>Accommodation</u>: The cost of Full Board Accommodation is:

 \in 55, person night (150.000 \$ Colombian money), accommodation double, triple and quadruple depending on the share of the hotel upon booking. Each room with two bathrooms.

€ 90, per night (240.000 \$ Colombian money), single room.

These values apply for every extra day and participants depends on the previous confirmation of each delegations interested in being a few days before or after the competition.

The "no-show" is penalty charged one night accommodation not occupied. It will be in charge of sports team and / or athlete and corresponds to the portion of the hotel plan.

You must tell the kind of accommodations you choose and the name of your companion, at the moment you fill your registrations form, it helps in order to make a pre check in and offer you the best service.

The last chance to make the reservation of your sport delegation will be at July 10 of 2010 and you must deposit the 50% of the rate established, according to the accommodation and nights chosen. 4. Transportation:

All local transportation in Bogotá will be available free of charge from Friday 23 January till Monday 26 January for all swimmers and team officials who stay in the hotel of the organization, as following:

- 1. From "El dorado" Airport Bogotá to the hotel and back.
- 2. Between hotel and competition place.

5. Swimming Pool:

The competition will take place at the "Centro de Alto Rendimiento", located in Bogotá City at Street 63 # 42-00.









Swimming pool length 50 meters, 8 lanes, depth 2.20 meters, electronic scoreboard Colorado Time System and about 500 spectator seats.

6. Nationals Flags:

We kindly ask each team to bring one national Flag with an approximate size of 1 m. x 2 m.

7. <u>Complaints</u>

CMAS Internacional Finswimming Rules will be applied with a fee of 100 €.

8. Classifications:

The classifications will be based on the times registered by the electronic system, and timekeepers. The results will be ruled by CMAS score.

9. <u>Prizes:</u>

<u>Individual prizes</u>: Medals will be given to the first-three classified athletes in every individual race and in the relay.

Be awarded a trophy for the best male and female Senior category, and the best male and female Junior category. In case of tie will be establishing the proportion of the mark made in any of the tests against the current absolute world record.

All participating clubs will receive a certificate of participation.

10. Equipment:

The swimmers equipment is ruled by CMAS international rules, this one will be check on Friday 13/08/2010, at technical meeting.

11. Observations:

- Doping testing is in compliance with CMAS (International Finsswimming Rules).
- The ceremony will take a place during the competition.







- During the ceremony the interested athletes must wear the official uniform of their team.
- Organizers reserve right for any change in the program. The teams will get all information about the changes on time.
- We suggest that the day you arrived to Bogotá Colombia changed your own money for local money (Colombian pesos)
